- Venue will remain the same as previous years in the lawn area
- Performance events—GDCNC has had performance events for Great Danes since the 1980s. The majority of members want to continue that tradition. The Santa Clara KC has changed their show date to the same as our GDCNC specialty, and SCKC offers performance for all breeds. We can request that SCKC exclude Great Danes from their performance events if we choose to offer performance at our Specialty. GDCNC would likely offer Great Dane performance on Saturday only.

Dail Koehler has researched Canine Good Citizenship (CGC) and tricks as part of the performance event, as well as locating an evaluator. Bea Moore is licensed in all obedience and may be willing to assist us.

Riney's dog club has offered CGC to the GDCNC at past shows.

Laura Craig, a former GDCNC member, is a CGC evaluator.

Sam and Dail will continue to check out options for performance events.

G. Unfinished Business

1. Distribution of funds from Pors estate—According to the Pors' wishes, monies received from their Great Dane collection (which were available at the 2019 GDCNC silent auction) should be donated to either the Great Dane Rescue of Northern California or the GDCA Charitable Trust.

Kate Jackson M/S Mabel Labiak to donate the proceeds of \$1070 from the GDCNC silent auction to the Great Dane Rescue of Northern California. Discussion ensued regarding the appropriate distribution of funds. <u>Motion passed</u>

Michelle Gillette M/S Lorrie spencer that the \$500 cash received from the Pors' estate be donated to the Great Dane Rescue of Northern California. <u>MPU</u>

2. Proposed language for bylaws regarding treasury auditing—Sam Gillette explained that there is some confusion about the language in the GDCNC bylaws that stipulates how an audit be performed on the financial records. Cindy Harwin will provide Sam with the GDCA verbiage regarding financial reviews. Michelle Gillette volunteered to look at the legal requirements for a small not-for-profit organization.
