- 3. Annual Board meeting held where we set the budget for the coming year.

G. Report of the Committees

1. Show Committee:

- We have a judging slate.
- We will have a match on Thursday night after setup. Laura is the match chair.
- We have Loren Bengston judging sweeps on Sunday. Looking for sweeps judge for Saturday.
- Jennifer Robb is assuming trophy chair. One day is a "goodie bag" of useful items for showing. Embroidered chairs for BISS. Many trophies will include an embroidered towel. Carrie is doing leads and leashes one day. Buckets for another day with things inside. Embroidered totes. Michelle gave Jennifer all the information that she has collected from her years as trophy chair in terms of the budget, guidelines for trophies and what trophies we have done in the past.
- Denise passed out a clipboard with trophy pledge sheet for both clubs looking for people
 to kick off the trophy pledges. After the annual meeting, Denise will begin soliciting
 donations on social media.

- **2. Education:** Melissa Pevy is no longer Education Chair. Denise is looking for someone to take that over.
- **3. Membership:** Pat Dousman no new membership applications
- **4. Ways and Means:** Lorrie Spencer –still have stashlights and key chains with GDCNC logo. No new ideas for new items. Michelle remembered that logo t-shirts and sweatshirts sold well at previous joint specialty. Jackets are another item that might be good. Michelle has provided the Board with digital copies of the logo.
- **5. Web site:** Kate Jackson—2024 specialty shows updates complete with a lot of new functionality. Will update with new officers after the election.
- **6. Discipline:** Sam Gillette—Nothing to report.
- **7. Legislation:** Kathy Bowler reported that there is nothing new going on, but she is keeping an eye on it.

H. Unfinished Business:

- 1. AKC PAC donation. Budget allows for \$500 in two categories, general and rescue. In 2024, \$250 paid to NAIA and \$250 to Great Dane Rescue. We do not need to decide on 2025 donation right now there are other things that we may want to donate to (e.g. S. CA disaster relief)
- 2. Michelle has been going through old meeting minutes and other items to make sure things are in order. In 2021, we changed a standing rule to provide for more categories of award plates that we use. The amount we spend on awards (plates, wooden plaques) has significantly gone up as a result. Cost comparison provided.
- **3.** Another issue from review of old minutes. 5 6 challenge trophies need plates updated annually to add new winners. In 2022, decided plate should include Ch or GCh and name should be taken from the show catalog. Issues/concerns:
 - 1. People are very passionate about their dog's titles.
 - 2. We have had people who will ask for a name different from what's in the catalog when asked this leads to confusion and more work for the club volunteer
 - 3. Club needs an accurate record of the registered name of the dog and the actual owners at the time of the win.

The minutes are a bit vague about "record for posterity." Do we need to clarify? No motion to clarify made.
