STATEMENT FROM THE ACTING PRESIDENT—Pete Fredotovich, Acting President, thanked Nancy Hawkes for the outstanding job she did while President of the GDCNC. He additionally thanked the Board and members of the GDCNC for their continued support while he steps in to fill the "big" shoes left by Nancy.

INTRODUCTION OF GUESTS—Debi and Gary Romerosa were introduced. They have submitted an application to join the GDCNC.

MINUTES—On a motion by Bill Labiak, seconded by Everett Van Dyken, the minutes of June 26, 2010 were approved as presented. Passed.

- **b) Membership:** Pat Dousman gave first reading for Gary and Debi Romerosa; they will be 1st-time published in next *Barker*. Kathy Bowler; Denise Matulich; Megan Hundley and Michael Wilcoxen; and, Jayne Peterson and Stephan Sam. have been 1st-time published and will be included for 2nd-time publication in next *Barker*.

NEW BUSINESS

- a) Appoint vacant board interim position (Terry Toops)—Acting President Pete Fredotovich, appointed Dana Wardner as the interim Board member, filling the vacancy of Terry Toops' term. On a motion by Laura Craig, seconded by Pat Dousman, the Board agreed to the appointment of Dana Wardner as Board member through the 2011 term. Passed.
- b) Appoint vacant Vice President interim position (Pete Fredotovich)— Acting President, Pete Fredotovich, appointed Laura Craig as the interim Vice President, filling the vacancy of Pete Fredotovich's term. On a motion by Everett Van Dyken, seconded by Pat Dousman, the Board agreed to the appointment of Laura Craig as Vice President through the 2010 term. Passed.
- c) Form and Appoint new Nomination Committee (committee resigned)—Acting President, Pete Fredotovich, appointed the new nomination committee as follows: Kathryn Netser, Ceil Wardner, and Paul Piccau. On a motion by Everett Van Dyken, seconded by Bill Labiak, the Board agreed to the appointment of Kathryn Netser, Ceil Wardner and Paul Piccau as the new nominating committee. Passed.
 - Ceil Wardner agreed to chair the committee. The committee will start from the beginning, consulting with incumbents to see if they want to run again in 2011.
- **d) GDCNC Banner**—On a motion by Everett Van Dyken, seconded by Pete Fredotovich, the Board approved the purchase of a color logo banner, at a cost of \$110, to be hung at the Nationals. Passed.

- e) Finance Committee—The Finance Committee may need to meet one to two more times to compare show costs prior to the 2011 specialty. The committee will meet on Thursday, October 7, 2010 at 5:30 p.m., Royce Farms (prior to the scheduled 6:30 p.m. Board meeting).
- **f) 2011 Match changes**—There was discussion among members as to what should be included at the match.
 - 2010 had puppies 6 to 18 months; other shows had puppies 3 to 12 months. What about 3 to 18 months?
 - The match is supported by the regular show (specialty). Maybe give prizes only to 1st through 4th place winners?
 - What about adding obedience/rally to the match?
 - Maybe have the match at a different time (date) than the show.
 - Possibly offer handling classes prior to the show or match.
 - Board will revisit this discussion after the show committee and match committee meet to discuss matters, then they will come back with suggestions for the show and match.
- g) Supported Entries—The Dixon supported entry had only three entries for Sweeps with only two showing up. Does the Board (budget) want to continue this practice with such low attendance? People admitted to not reading the premium lists and just signing up for classes through infodog. Should the club email all members (and other clubs) to let them know when there is a sweepstakes?



A great new tool for breeders, brought to you by Laura Munro

I just finished building Dane Quest, a Web-based stud dog submit and search application for Great Dane breeders and stud owners. Stud dog owners can submit stud dogs to be added to the database. When they submit a stud dog, they provide identifying information about the dog, his owners and breeders and a picture. They also give an objective evaluation of the dog based on criteria outlined in the standard. Once the record is in the database, breeders that are looking for dogs that excel in specific criteria can search on that criteria and the matching dogs are retrieved. The results page includes the picture of the dog and the identifying information about the dog and the contact information for his owners and breeders. These are not glitzy ads that people typically find in the hardcopy and online magazines. The goal is to provide visibility to stud dogs available worldwide to breeders. This is an international tool and includes registries for every FCI, AKC and CKC registry in the world.
