## **TREASURER'S REPORT**

Bill Labiak reviewed the financial reports for March, April and May 2010.

The five-year audit is complete and it came out fine. The total cost of the audit came to \$1100 rather than the \$1800 as approved.

Laura Craig made a motion, seconded by Jenny Kenton, that the Club purchase a plaque, at a cost not to exceed \$50.00, to recognize the good service Dana Wardner gave as Treasurer for about 10 years. Passed. Pete Fredotovich will purchase the plaque.

Bill Labiak reviewed the 2010 Show Summary. The silent auction is not included in that summary as donations went directly to GDCA. The silent auction brought in \$795 for GDCA. Show income totaled \$12,969 with expenses at \$11,810, bringing in a net income of \$1,158.47. It was noted that \$400 included in the raffle cost was cash for the cash box and; therefore, offset in the raffle income.

- Denise Williams asked if we could allow a broader range for age groups in the match next year. Show committee will check this out.
- Power and parking fees will go directly to Riney next year.
- Board had good responses about the BBQ. Need more macaroni and cheese.
- Move BBQ closer to ring/RVs next year.
