The meeting was adjourned at 12:35 pm.



GDCNC Health Clinic



Dr. Lori Siemans, a board-certified cardiologist, will be available to do echocardiograms at Saturday's show (April 26th). She'll have the forms for OFA submission available, too. This is a great opportunity to get your dogs' heart health certified -- for only \$125!

An echocardiogram uses ultrasound waves to create an image of the heart, providing a picture of overall heart structure and function. A normal echocardiogram displays normal heart chambers and valves. It also shows normal heart movement. An abnormal echocardiogram may indicate cardiomyopathy or a number of other heart abnormalities.



No preparation is required for an echocardiogram; the dog lies on its side and the doctor places a device called a transducer on the chest and aims it at the heart. The transducer sends out and receives sound waves that bounce off the heart. A computer takes these returning sound waves, or echoes, and turns them into a picture of the heart. The procedure should only take about 5 minutes.

There's a limit of about 15 dogs -- and places are filling fast. Email kate@qantel.com if you want one or more of your dogs to be included.
