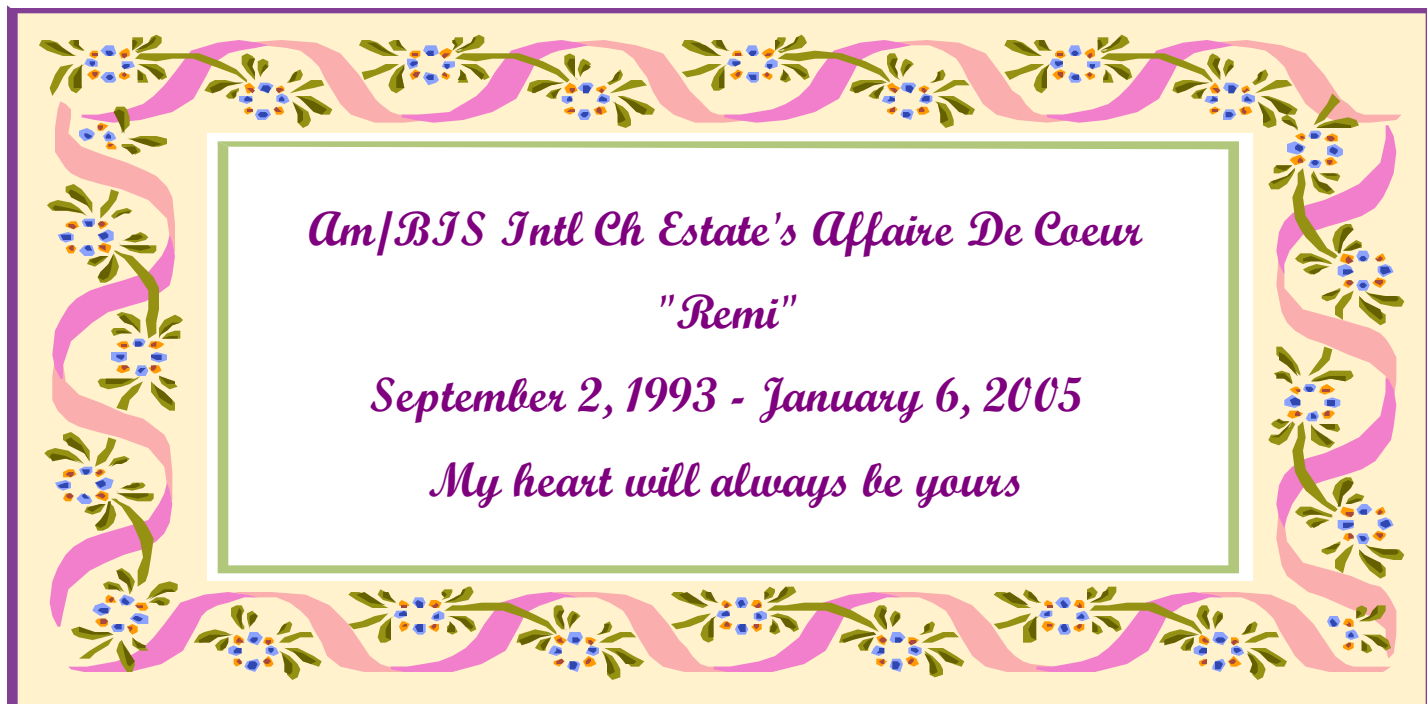

Dear Affiliate Clubs,

I am sending this letter out to all the GDCA Affiliate Clubs to ask that each dub appoint someone to poll all active members of that dub for good quality veterinarians and emergency veterinarians that they would recommend that others use. Examples of who could use this information would be a new person moving into the area that needs a reference, or a visitor to the area that needs to find a vet to assist them that is experienced in treating Great Danes. This type of list can be found on the GDCA website under the Great Dane pull down menu, Health and Welfare and Emergency Clinics listing. You can click on the Veterinarians in the Minneapolis Metro Area to see the type of listings the GDCA is trying to obtain. This request went out to all dubs once before, but we did not get the turnout that we would have expected and we would like to update and add to what is in place already. I urge everyone to join together to accomplish this for the sake of our dogs in case of an emergency or any other reason. The existing list has come in handy many times since it has been available. My own dub, the Heart of Minnesota GDC, has a website with a link to the GDCA website that takes the user right to this information. Our club has had several comments on the valuable information that is listed there from many different people that have accessed our website. If you could please reference the Heart of Minnesota GDC Emergency Vet Listings link, on the GDCA website, as a guide, it would be appreciated.

Feel free to contact me if you need any assistance in this matter. I will be glad to do whatever I can in order to make more information more accessible to anyone and everyone who might need it.

I ask you all, to please help make a huge effort in this project, so that it can be updated for everyone to use. It could save the life of your dog.

The form on the reverse side of the page contains all information needed about the recommended veterinarian, and also contains a section which the vet should sign, giving his or her permission to be listed on the website. If you need additional forms, please let me know. Please send all completed forms to me at the address above, and I will see that it gets updated on the GDCA website.

Chalk Up Another Title for Titan

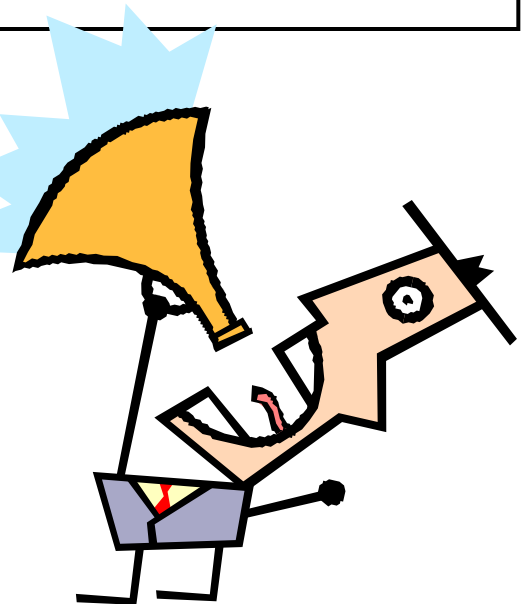

Your Dogs' Achievements – Recorded For Posterity

For several years, GDCA Yearbooks have been available at the National to feature our dogs' accomplishments during the previous year – we're working on the 2004 Yearbook that we'll be presenting in Arizona. GDCA and affiliate club members are entitled to a free ad for any of their dogs that in 2004 did one or more of the following:

- completed its championship
- earned an obedience or agility title
- got CGC certification
- received two or more of the following health certifications: hips, elbows, CERF, cardio and/or thyroid (list all; only one needs to have been obtained in 2004)

Historically, ad material has been submitted primarily by regular mail (an advertising form is included in this newsletter), and it's been up to yearbook volunteers to scan pictures and transcribe health, title, owner, breeder and pedigree details. While sending your ad stuff via regular mail is still an option, it'd be lots easier for the GDCA yearbook elves to receive your ad electronically. If you do send your ad info via email, it's a good idea to take a look at the advertising form anyway since it also includes info about ordering your copy of the yearbook.


If you decide to submit your ad via email, you'll need to include all of the following information – it's preferable that it be typed in the body of the text so we can copy directly from it (i.e., as opposed to a scanned pedigree which we'll have to retype). Here's what your ad submission must include:
