## First Aid Report

The August 23rd. GDCNC sponsored First Aid and CPR course presented by Margie Trebino was a great success! Most of those in attendance came from long distances; San Pablo, San Mateo, Marysville, San Jose. Only two of us were locals.

Attendance was limited to 20 people so that everyone had a chance to apply their knowledge to our "furry friends". (Numerous almost life-size stuffed dogs and cats) Twist, Margie's real dog, also offered her services to locate femoral pulse. Much like ET,

Twist was well hidden among the "furry friends" and Royce Farm owners never realized one of those critters on the table was actually breathing! Giant Schnauzer,

Rottweiler, Labrador and a Dane person spent a very informative and socially enjoyable few hours practicing all aspects of emergency first aid and CPR.

Margie provided a medium size CPR dog dummy and a CPR cat dummy to practice on. Most participants struggled with the amount of air flow to inflate the dog's lungs! It is almost imperative that two or even three people be able to work in unison on a giant breed dog so it behooves you to have several family members and/or friends trained in CPR methods for animals. Regarding the cat......well by the time we all got good on the dog the cat either had it's lungs blown out it's rear-end or if you weren't holding it correctly you got to watch in horror as it blew down the length of the table and off the end!

Hello Kitty.....Sorry Kitty.....Goodbye Kitty......Thank goodness for nine lives!

Participants were given certificates
good for 2 years, just like Red
Cross CPR certificates, an easy
reference booklet to carry with
you and several forms for evaluat-

ing your dog's health, baseline vitals and emergency numbers.

Finally, we built our first aid kits with all the items commonly needed and some breed specific items. Note worthy to mention is that most items in a first aid kit date expire and/or are adversely effected by heat, so either make sure you replace everything every 4-6 months if you keep your kit in the RV or car. Extend that life by keeping your kit in the house and taking it with you only when you leave, much like you would your purse. The same goes for bottled water.

Also discussed were disaster kits and how these were different than first aid kits. Always leave emergency/identification information on the refrigerator. Rescue personnel are trained to look there first when entering a house.

Thank you to Margie Trebino for providing this workshop at a discounted rate to the GDCNC. And thank you to our education chairperson, Barbara Moffett for continuing to obtain and provide a wide variety of educational opportunities.



Urbana, III., August 21, 2006—The
ASPCA Animal Poison Control Center cautions
animal owners that xylitol, a sweetener found
in certain sugar-free chewing gums,
candies, baked goods and other
products can potentially cause serious
and even life-threatening problems for
pets.

"Last year, we managed more than 170 cases involving xylitol-containing products," says Dana Farbman, CVT and spokesperson for the Center. "This is a significant increase from 2004, when we managed about 70." Barely halfway into 2006, the Center has already managed about 114 cases. Why the increase? "It's difficult to say," Farbman states. "Xylitol products are relatively new to the United States marketplace, so one possibility may be an increase in availability."

According to Dr. Eric Dunayer, veterinarian and toxicologist for the ASPCA Animal Poison Control Center, dogs ingesting significant amounts of items sweetened with xylitol could develop a fairly sudden drop in blood sugar, resulting in depression, loss of coordination and seizures. "These signs can develop quite rapidly, at times less than 30 minutes after ingestion of the product. Therefore, it is crucial that pet owners seek veterinary treatment immediately." Dr. Dunayer also stated that there appears to be a strong link between xylitol ingestions and the development of liver failure in dogs.

While it was previously thought that only large concentrations of xylitol could result in problems, this appears to no longer be the case. "We seem to be learning new information with each subsequent case we manage," says Dr. Dunayer. "Our concern used to be mainly with products that contain xylitol as one of the first ingredients. However, we have begun to see problems developing from ingestions of products with lesser amounts of this sweetener." He also says that with smaller concentrations of xylitol, the onset of clinical signs could be delayed as much as 12 hours after ingestion. "Therefore, it is important to keep in mind that even if your pet does not develop signs right away, it does not mean that problems won't develop later on."

The ASPCA Animal Poison Control Center strongly urges pet owners to be especially diligent in keeping candy, gum or other foods containing xylitol out of the reach of pets. As with any potentially toxic substance, should accidental exposures occur, it is important to contact your local veterinarian or the ASPCA Animal Poison Control Center for immediate assistance.

# Dangers of Chewing Gum



Last Friday evening, I arrived home from work, fed Chloe, our 24 Lb. dachshund, just as I normally do. Ten minutes later I walked into the den just in time to see her head inside the pocket of Katie's friend's purse. She had a guilty look on her face so I looked closer and saw a small package of sugar-free gum. It contained xylitol. I remembered that I had

recently read that sugar-free gum can be deadly for dogs so I jumped on line and looked to see if xylitol was the ingredient. I found the first website below and it was the one.

Next, I called our vet. She said to bring her in immediately. Unfortunately, it was still rush hour and it took me almost 1/2 hour to get there. Meanwhile, since this was her first case, our vet found another website to figure out the treatment. She took Chloe and said they would induce her to vomit, give her a charcoal drink to absorb the toxin (even though they don't think it works) then they would start an iv with dextrose. The xylitol causes dogs to secrete insulin so their blood sugar drops very quickly. The second thing that happens is liver failure. If that happens, even with aggressive treatment, it can be difficult to save them. She told us she would call us.

Almost two hours later, the vet called and said that contents of her stomach contained 2-3 gum wrappers and that her blood sugar had dropped from 90 to 59 in 30 minutes. She wanted us to take Chloe to another hospital that has a critical care unit operating around the clock. We picked her up and took her there. They had us call the ASPCA poison control for a case number and for a donation, their doctors would direct Chloe's doctor on treatment. They would continue the iv, monitor her blood every other hour and then in 2 days test her liver function. She ended up with a central line in her jugular vein since the one in her leg collapsed, just as our regular vet had feared.

Chloe spent almost the entire weekend in the critical care hospital. After her blood sugar was stabilized, she came home yesterday. They ran all the tests again before they released her and so far, no sign of liver damage. Had I not seen her head in the purse, she probably would have died and we wouldn't even had known why.

Three vets told me this weekend, that they were amazed that I even knew about it since they are first learning about it too. Please tell everyone you know about xylitol and dogs. It may save another life.

In a plastic bucket, mix well the following ingredients:

- ♦ 1 quart of 3% Hydrogen Peroxide
- ♦ 1/4 cup of baking soda
- ♦ 1 to 2 teaspoons liquid soap

for very large pets one quart of tepid tap water may be added to enable complete coverage.

Wash pet promptly and thoroughly, work the solution deep into the fur. Let your nose guide you, leave the solution on about 5 minutes or until the odor is gone. Some heavily oiled areas may require a "rinse and repeat" washing.

Skunks usually aim for the face, but try to keep the solution out of the eyes - it stings. If you have any cuts on your hands you might want to wear latex gloves for the same reason.

After treatment, thoroughly rinse your pet with tepid tap water.

Pour the spent solution down the drain with running water



## **NEVER**,

ever, store mixed solution in a closed bottle, sprayer, etc. Pressure will build up until the container bursts. This can cause severe injury.



# More notes on getting the "Pee-Yew!" out of your pooch!

- Clean plastic mixing containers and utensils are preferred. Metals encourage auto-decomposition of the peroxide.
- Hydrogen Peroxide 3% solution is usually sold in pint (500ml) bottles, so you'll need two. The 3% grade is often marked "U.S.P.", meaning that it meets the standards for medical use and purity as set forth in the United States Pharmacopoeia.

The use of other strengths/grades is not recommended unless you're a chemist, and even then a trip to the 24-hour drugstore is much better than a trip to the emergency room.


- Use baking soda, not baking powder. "Arm and Hammer" is one popular brand. Baking soda is also called: Sodium Bicarbonate, Sodium Bicarbonate, U.S.P., Bicarbonate of Soda, and Sodium Hydrogen Carbonate. Do not confuse any of the above with Washing Soda, which is Sodium Carbonate. Washing Soda is about 100 times more alkaline than Baking Soda and can cause skin burns to both you and your pet.
- Two preferred brands are "Softsoap" and "Ivory Liquid". As far as auto-decomposition of the peroxide is concerned, the surfactant package in these two is fairly inert. Heavy-duty grease-cutting brands such as "Dawn" are less inert, and hair shampoo is probably the worst.
- Once mixed, the peroxide slowly breaks down into water and oxygen gas. Thus it gets weaker with time and so it should be used promptly. The exact rate depends on temperature, pH, and catalysts such as trace amounts of metals (iron,etc.) in the soap and/or tap water.

How much pressure will the complete decomposition of 3% hydrogen peroxide produce in a closed container ??? It depends on how full the container is. Assuming negligible solubility of Oxygen in water, a bottle half-full of peroxide will develop about 140 psi. A bottle 3/4 full would develop 420 psi. This can do a lot of damage.

Highly pure hydrogen peroxide decomposes very slowly if kept cool and in a dark place, a few percent a year. The more dilute solutions usually decompose faster (due to impurities in the dilution water) and have a trace of stabilizer added. So why aren't the bottles in the store bloated or bursting? Look carefully inside the cap... you'll see some very tiny holes in the cap liner to let the oxygen gas escape. A good reason to always store bottles upright.

Look for an expiration date on your peroxide. If you're using stuff which has been sitting around in your medicine cabinet for years, buy fresh peroxide.

- Tepid: lukewarm.
