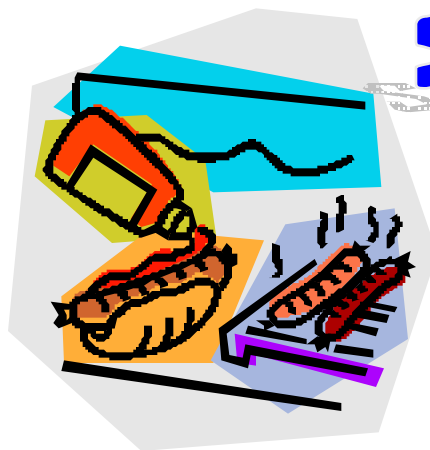

## Opinion: Veterinarians Should Oppose Ear Cropping Bans

Club member Kitty Kenyon, a veterinarian, has written the letter below to the CVMA Board. She encourages club members to revise it and ask their own veterinarians to sign it and send it to the CVMA Board as well. We need to get our veterinarians involved to stop this infringement on our rights.

Dear CVMA Board,

I am writing you to express my opposition to AB418, the proposed ban on ear cropping. I urge the board to adopt a position against this bill. I am a veterinarian and I do perform ear cropping surgery in my practice. The ear crops are performed like any other surgery—with modern analgesics, fluids and anesthetics. This bill will take ear cropping out of the hands of licensed veterinarians. It will not stop ear cropping. There will be more owners doing their own crops or lead to unscrupulous individuals offering illegal crops with crude and painful methods.

This bill will establish a dangerous precedent that replaces the professional judgment of the veterinarian with laws designed to enforce the beliefs of special interest groups. This bill encroaches upon the relationship between my clients and me as their veterinarian.

I believe that dog owners should be able to continue to make animal husbandry decisions based on their own experiences and the medical professionals they rely on. I believe as a veterinarian, I should have the choice to perform ear cropping just as I have the choice to specialize in other types of procedures in my practice. The practice of veterinary medicine should be left to the veterinarians and not be dictated to us by legislators and radical animal rights extremist groups.

Please consider the long term implications that this legislation will have on the practice of veterinary medicine. This is only the first step. Legislators do not dictate to medical doctors. There is no proposed ban on tummy tucks, breast enhancement and the like. In fact there are probably a lot of veterinarians with their bodies pierced or who have had cosmetic surgery performed on themselves. As for the argument that the animals can not object to the surgery, can newborn babies object to having their ears pierced at birth? No one has suggested banning that.

If we go with the thinking that the animals can't object, then we should ban spaying and neutering. A male dog would certainly want to stay in tact, keep his hormones and breed bitches. Now how ridiculous is that? Dog owners have the right to make informed decisions on the procedures and care that their animals receive.

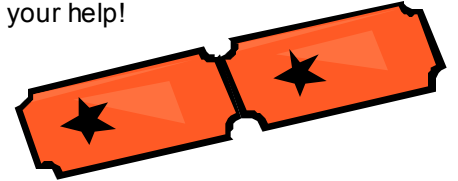
I also breed Great Danes and most of my pet puppy buyers choose not to crop their puppies' ears. So ear cropping is dying out without legislation.

- M/S/P to set up Standing Rules. Everett will be head of the committee.

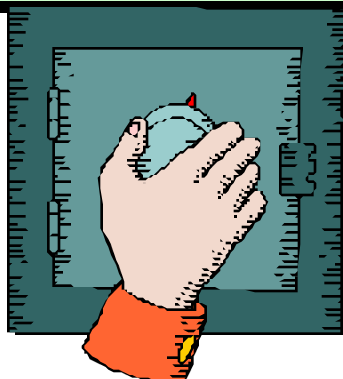
The next meeting will be on May 14<sup>th</sup> in Woodland after Dane judging at the Camellia Capital show.
