Have you discovered a website called "ShowDays.Info"? It's been out there since last June, but I just came across it yesterday. I know once in awhile you go collect the info and make a show listing for CA, NV, WA, OR, & AZ, and send it out for the rest of us to use. I know it's work and takes time to do it. This site just ran that same report for me in 9 seconds and gave me a whole lot of other data (not that yours wasn't good, it's just that this one has more).

If you haven't tried it, you should! It locates all the show data you would ever want or may want some day: by one or by multiple states, and by one or by multiple breeds, highlighting specialty shows. You can get show listings for any time frame on the AKC's online show calendar (which is currently out to early 2007).

It has all the right hyperlinks including: supers, club websites, past entry counts, judges (breed, Group & BIS), dosing dates, entry fees — it seems to have just about everything you would want or need for show planning, including driving instructions.

The best part is that anyone can get a report for free, and you can copy it or download it. There's an option to join for \$30/year for advanced features which includes storage and making things more personal.


2005 GDCA Yearbook Submission: The Deadline is June 1st



AKC Code of Sportsmanship

The following *Code of Sportsmanship* was recently adopted by a unanimous vote of the AKC Board of Directors.

PREFACE

The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- ◆ Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- ◆ Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- ◆ The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- ◆ The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- ◆ The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- ◆ Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- ◆ Sportsmen welcome, encourage and support newcomers to the sport.
- → Sportsmen will deal fairly with all those who trade with them.
- ◆ Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- ◆ Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dogs.
- ◆ Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.



And Mouse — Wait!!! Who's Mouse???





# CGC Testing to be Offered at Specialty

AKC Canine Good Citizen (CGC) testing will be held on Saturday through the courtesy of the Golden Valley Kennel Club at a cost of \$10. Bring a 6-foot leash, proof of rabies vaccination, brush (optional) and, of course your dog. It is a fun and eye-opening activity that will increase your appreciation of your dog's abilities.

Started in 1989, CGC is a certification program that is designed to reward dogs who have good manners at home and in the community. The Canine Good Citizen Program is a two-part program that stresses responsible pet ownership for owners and basic good manners for dogs. All dogs who pass the 10-step CGC test may receive a certificate from the American Kennel Club.

Many dog owners choose Canine Good Citizen training as the first step in training their dogs. The Canine Good Citizen Program lays the foundation for other AKC activities such as obedience, agility, tracking, and performance events. As you work with your dog to teach the CGC skills, you'll discover the many benefits and joys of training your dog. Training will enhance the bond between you and your dog. Dogs who have a solid obedience education are a joy to live with-they respond well to household routines, have good manners in the presence of people and other dogs, and they fully enjoy the company of the owner who took the time to provide training, intellectual stimulation, and a high quality life. We sincerely hope that CGC will be only a beginning for you and your dog and that after passing the CGC test, you'll continue training in obedience, agility, tracking, or performance events.

Canine Good Citizen® is one of the most rapidly growing programs in the American Kennel Club. There are many exciting applications of this wonderful, entry level that go beyond the testing and certifying of dogs.

Many other countries (including England, Australia, Japan, Hungary, Denmark, Sweden, Canada, and Finland) have developed CGC programs based on the AKC's CGC Program. A CGC Neighborhood Model has been established, police and animal control agencies use CGC for dealing with dog problems in communities, some therapy dog groups use the CGC as a partial screening tool, and some 4-H groups around the country have been using the CGC as a beginning dog training program for children.

A number of specialty (one breed only) clubs give the CGC at their annual national dog show. Dog dubs have discovered that the CGC is an event that allows everyone to go home a winner. Veterinarians have recognized the benefits of well-trained dogs and there are some CGC programs in place in veterinary hospitals. State legislatures began recognizing the CGC program as a means of advocating responsible dog ownership and 22 states now have Canine Good Citizen resolutions.

In a little over one decade, the Canine Good Citizen Program has begun to have an extremely positive impact in many of our communities. This is a program that can help us assure that the dogs we love will always be welcomed and well-respected members of our communities.

The CGC test is performed on-leash attached to either a flat buckle or slip collar. The handler can praise and encourage the dog, but no toys or food rewards can be used. The test includes the following ten exercises:

Test 1: Accepting a friendly stranger

Test 2: Sitting politely for petting

Test 3: Appearance and grooming

Test 4: Walking on a loose lead

Test 5: Walking through a crowd

Test 6: Sit & down on command and stay in place

Test 7: Coming when called

Test 8: Reaction to another dog

Test 9: Reaction to distraction

Test 10: Supervised separation
