 - BIS, BISS and Top 20 placement.

M/S/P - To approve the minutes of the July 29, 2002 meeting as published in the newsletter.

Reports of Officers: President: Everett reminded everyone of upcoming meeting dates: October 26, after Dane judging at the Dixon show. November 2, (Board only).

Nominating Committee:

Everett named Bobbie Malloy and Timmie Williams to the Nominating Committee, and he needs one more person.
