## **Campaign Against Breed Profiling**

The Doberman Pinscher Club of America (DPCA) has launched a campaign against breed profiling — an issue of concern, not just to Doberman people, but to owners of many other breeds. Since Dobermans are a breed that are frequently and unfairly targeted, the DPCA has been working hard to overturn breed restrictive policies wherever they occur. The club was recently successful in getting American Airlines to rescind its ban on shipping so-called "aggressive" breeds. Now Jeffrey P. Helsdon, a Washington State attorney and Legislative Director for the DPCA, reports on his attempt to prevent insurance companies in his state from taking a dog's breed into consideration when writing insurance policies for dog owners.

Helsdon and his supporters managed to get two bills introduced into the Washington legislature. The first prohibited insurance carriers from engaging in breed profiling; the second included the provision that "the breed of a dog shall not be a determining factor when declaring a dog potentially dangerous or dangerous." Unfortunately neither bill was enacted into law, but both gained enough support from public and legislators to encourage optimism that they may be reconsidered when the Legislature returns after its summer recess.

Helsdon notes that the public is behind such bills, thanks to media stories such as one that aired recently on CBS Evening News: in that piece, a little girl was interviewed after insurance problems obliged her parents to get rid of the family pet. "We are starting to win the battle for public opinion, Helsdon says. He also provides suggestions for action that concerned breed clubs can take:

First, identify state legislators who serve on committees concerned with insurance. (This information is available on the state website). Then invite these legislators to dog shows to present Group awards — "Distinguished Award Presenters," Helsdon calls them. He regards this as an extremely important part of the campaign, for "they get to see us in our venue, when we appear most organized — a dog show. What they immediately see — and this is where we make an impression — is: Voters. Organized Voters. Motivated, Organized Voters with a cause." He adds, "I also like to invite the League of Women Voters to put up a Voter Registration booth. You don't have to mention it at all to the VIPs — they get it."

At the show, someone should explain to invited VIPs what is going on. If they sit with the judges who are watching the groups, they will get to know members of the fancy. When VIPs present the Group trophies, the announcer should explain who they are. (Judges, of course, must present the ribbons.) A photo of the VIP and the winning dog is an excellent reminder of the event.

Helsdon suggests that legislators should be asked ("gently") to support laws eliminating breed profiling while they are at the show. They can be provided with a copy of Washington state HB 1895 as a model for local legislation. (This is available at http://www.leg.wa.gov/pub/billinfo/2003 04/House/1875 1899/1895.pdf.) Helsdon notes, "You may be surprised at the enthusiastic support that you will get." And finally, he urges, talk to the representative of your own district, as well as to those on the relevant House or Senate committees. Let them know that you care about the issue of breed profiling.
