SPECIALTY SHOW:

- Auction monies discussion was tabled until the next meeting.
- Regarding having Sweepstakes both days: Saturday's Sweeps judge is secured but we still need a judge for Sunday's Sweeps. Everett will contact Lucretia to get the name of her friend in Alaska.

UNFINISHED BUSINESS:

- Holiday Brunch at the Pleasanton Hotel
 - We discussed keeping the cost the same as in previous years (\$25 per person). We addressed having a slightly higher fee for late reservations but nothing was set. The Club is willing to cover any costs over the \$25 per person meal ticket.
 - There will be no awards ceremony in conjunction with the brunch this year so there will be more time to socialize. In addition we have reserved the venue for an additional hour – even more time to socialize.
- Overage of the new trailer
 - M/S/P to approve that overage costs of the trailer are not to exceed \$500.00. The total cost of the trailer is \$6,470.00.
 - M/S/P to approve not to spend in excess of \$750.00 to build/rebuild the shed to house the new larger trailer.
- Standing Rules: Discussion on standing rules tabled.

NEW BUSINESS:

- GDCA health Testing Ballot: Jane did a brief introduction to the ballot and health testing in general. She explained that the ballot has received much discussion on many levels, essentially the parent club wants to encourage health testing. The 4 ballot items were read and the club vote was cast on the 4 ballot items:
 - Yes on one parent having at least one test for Futurity
 - o No on CHIC requirement for Futurity parent

- o Yes on stud dog/brood bitch having at least one health test
- Yes on CHIC for breeder referral (GDCA)
- Disaster Relief: The club has a \$2000.00 CD for disaster relief it was discussed donating a portion of this to the AKC to aid in relief. It was noted that by donating to AKC/CAR Canine Support and Relief Fund that 100 % of the monies would go directly to the relief effort.
 - o M/S/P to donate \$1000.00 to AKC/CAR to help with the animals that were affected by hurricane Katrina.

MEETING SCHEDULE:

M/S/P – to approve the next meeting date to be on Octoer 29th following Great Dane judging at the Sacramento show in Dixon. It was felt that earlier would be too difficult with so many traveling to the National.

GDCA CONSTITUTION:

M/S/P – to approve the new wording of the GDCA Constitution as written.


