
#### **Laural Picks Up Four** Points In Petaluma




Ch Rockingdane's Nvr A Dull Moment x Blanton's Country Affaire February 23, 2003 ~ October 13, 2007

### SKUNKED?

The most effective de-skunking recipe is this one:

- 1 quart 3% hydrogen peroxide. Be sure to use a fresh, unopened bottle as hydrogen peroxide eventually turns into water
- 1/4 cup baking soda
- 1 teaspoon liquid soap

Here's why it works: hydrogen peroxide and baking soda, when combined, become a "chemical engine" for churning out oxygen. That's why it has to be used immediately after mixing. The soap breaks up the oils in the skunk spray, allowing the other ingredients to do their work.

Combine the ingredients in an open container. Wearing gloves, wash your dog with the mixture while its bubbling. Work the mixture in well, concentrating on the area that was sprayed. Keep it away from your dog's face and eyes (it's a harsh solution). Let the mixture stand for 10 minutes or so before rinsing off.
