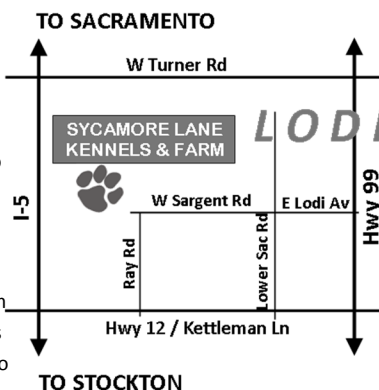

From Interstate 5:

Take Hwy 12 exit (Lodi/Rio Vista). Head East for 1.3 miles to Ray Road. Turn left onto Ray Road and go almost one mile to the first curve. At the curve, turn left onto Sargent Road and follow the signs to Sycamore Lane Kennels and show site.

From Hwy 99:

Take the Kettleman/Hwy 12 exit. Proceed through Lodi. From the last traffic signal (Lower Sacramento Road), it is 3.5 miles to Ray Road. Turn right onto Sargent Road and follow signs to Sycamore Lane Kennels and show site.



Parking

Parking is provided and managed by Sycamore Lane Kennels. Day of Show Parking is available on a limited basis at a fee of \$5.00 per vehicle per day.

Parking hours are 1:00 PM to 10:00 PM on Friday, and 6:00 AM to 10:00 PM on Saturday. Gates will open at 6:00 AM on Sunday. No vehicles in day lot are allowed to remain overnight. No "in and out" privileges are available. You will be charged \$5.00 if you leave and return to the grounds. No RV parking is permitted in the Day of Show parking area.

Obedience "OC" and Rally "RC" Match: Classes offered: Novice, Open, Utility, and a Rally nested course for Novice, Advanced and Excellent. \$10 per run-through with maximum 10 minutes in the ring (except 15 minutes for Utility). **No food permitted in the performance rings.** Toys are allowed. Collars must comply with AKC regulations. Corrections limited to verbal corrections or gently guiding the dog. Bitches in season are not permitted to participate. Entry fee \$10. Day of match entries will be accepted starting at 3:30PM; the match begins at 4:00PM.
