## Schedule of Championship Points

The Points towards a Championship shall be awarded to the Winners Dog and Bitch, based on the actual number of dogs or bitches competing in that breed or variety. Only dogs entered and judged in the Regular Classes will be counted as being present for the purpose of Championship rating.

Any dog which shall have won fifteen points shall become a Champion of Record, if six or more points shall have been won at two shows with a rating of 3 or more Championship Points each and under two different judges, and some one or more of the balance of the points shall have been won under some other judge or judges than the two judges referred to above.

The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records. Winners of the Veteran Dog and Veteran Bitch Classes may also compete in the Best of Breed Competition, provided that they are undefeated in any Regular Class at this show.

### OWNER-HANDLED BEST OF BREED

This event qualifies for the AKC National Owner-Handled Series (NOHS). Exhibitor must check the Owner-Handled checkbox on the entry form to be eligible. See information on Page 7.

**Stud Dog Class** - For Stud Dogs and at least two but no more than four of their Get. Stud Dog may be entered separately in one of the regular classes or if a Champion of Record in Best of Breed Competition, but **MUST** be entered in the Stud Dog Class. Stud Dog entry fee is \$20.00; the Get **MUST** be entered in one of the regular classes. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

**Brood Bitch Class** - The same as Stud Dog except substitute Brood Bitch for Stud Dog, and Produce for Get.

**Brace Class** - Two Great Danes which must have at least one common owner and to be presented by a maximum of two handlers. The dogs comprising a Brace **MUST** be named at the time of entry. Both dogs must be entered in another conformation class. Mark "Brace Class" in the space provided for Additional Classes. If more than one Brace is entered by the same owner, the dogs comprising EACH Brace must be so designated: "Brace No. 1, Brace No. 2," etc.

**Team Class** - Four Great Danes which must have at least one common owner and to be presented by a maximum of four handlers. The dogs comprising the Team **MUST** be named at time of entry. The four dogs must be entered in another conformation class. Mark "Team Class" in the space provided for Additional Classes. If more than one Team is entered by the same owner, the dogs comprising EACH Team must be so designated: Team No. 1, Team No. 2, etc.

This Sweepstakes is open to all Great Danes who are at least 6 months and under 18 months of age on the day of the show. Dogs entered in Sweepstakes must be entered in a Regular Class. Champions of Record are not eligible to compete in Sweepstakes. Sweepstakes will be judged prior to the Regular Classes. Indicate "Sweepstakes" and age division on the regular entry form under "Additional Classes." Entry fee is \$22.00.

- NOVICE CLASS - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member club show.
- OPEN CLASS - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have won three (3) first place awards with competition present, in a Novice Class at a licensed or member club show.
- MASTER CLASS - For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who, at the time entries close, have won ten (10) First Places, with competition present, in an Open Class at a licensed or member show. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry without charge, the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

BEST JUNIOR HANDLER to be selected from the winners of each Junior Showmanship class. Competition not required.



## AKC National Owner-Handled Series

Offered All Three Shows

### Determining Eligibility:

- \* Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the CHECK BOX on the entry form.
- \* The handler must be an owner of record according to the AKC's records as of the date of the show.
- \* Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog.
- \* Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend.
- \* Dogs must be handled by an owner-handler eligible for AKC NOHS throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC NOHS competition.
- \* The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. *This excludes all dogs defeated during class and winners competition for the regular show.*

### Determining Owner-Handled Best of Breed

- \* Breed judging for OH Best of Breed is conducted following Best of Breed judging in the ring. All dogs in BOB competition (including WD & WB) will stay in the ring after the judge makes their placements. The ring steward will ask all professional handlers, household members, and current assistants to a professional handler, and any exhibitor that did not indicate on their entry that they were eligible for NOHS to leave the ring. The judge will then select the Owner-Handled Best of Breed. A dog being "cut" or otherwise "defeated" in the BOB ring remains eligible to compete for OH Best of Breed.

## Parade of Title Holders, Veterans & Rescue Dogs

Saturday Only

The non-competitive Parade is open to all Great Danes, six months & over, that are:

- Title Holders – Great Danes which hold any title or certification – champion, obedience, rally, agility, tracking, CGC, therapy, etc.
- Or, Veterans – Great Danes 6 years or older.
- Or, Rescues – Great Danes that were obtained from a rescue group.

Each participant will receive a rosette imprinted with the dog's name.

## Notice To Exhibitors

1. Telephone, Conditional and Unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms or photocopies of Entry Forms without Agreement and Rules on the reverse side of entry form are NOT ACCEPTABLE. Entries without fees are not acceptable. Fees must accompany entries.
2. Post dated checks and returned checks do not constitute a valid entry fee. The Club will add a collection fee of \$25.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor(s) may result in their being put on a CASH ONLY basis.
3. **PLEASE TYPEWRITE or NEATLY PRINT** all entries. Use black or blue ink. Do not use pencil.
4. **CHANGES, ADDITIONS OR CORRECTIONS** to entry forms must be received **IN WRITING** prior to close of entries. Changes are not acceptable by telephone. E-mail or faxed changes are allowed.
5. **ERRORS ON ENTRY FORMS** — Owners alone are responsible for the correctness of entries, or for entering the same dog twice, or for entering a dog in a class in which the dog is ineligible to compete, regardless of who makes such errors. No entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date and time. Due to cost of processing, no refunds less than \$4.00 will be made.
6. **FIRST ENTRY OF EACH DOG IN CONFORMATION OR OBEDIENCE** includes an AKC Recording Fee of \$.50. In addition, each entry of a dog in single-entry recording classes includes \$3.00 AKC Event Service Fee. These fees are required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test and are collected by the show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, these fees are collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2). Each first rally entry of a dog (per trial) includes a \$3.50 AKC Recording Fee and each additional rally entry includes \$3.00 AKC fee.
7. **ENTRY FEES WILL NOT BE REFUNDED** in event a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Event's Show Committee. If, because of riots, wars, civil disturbances, fire, Act of God, strikes, national emergencies, health emergencies, extreme weather conditions (including but not limited to extreme heat, floods, hurricanes, lightning, or earthquakes), or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made. The well-being of dogs, exhibitors, and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.
8. **ACKNOWLEDGEMENT OF ENTRY AND SCHEDULE OF JUDGING TIME** will be sent to the address on the Official AKC Entry Form after the closing date, as soon as practicable. If an exhibitor has not received a copy of the Schedule within seven days of the show, please notify the Show Secretary.
9. **DECLINATION OF ENTRIES:** The Club may decline any entry for cause, and may refuse to receive, or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.
10. **PLEASE NOTE:** Dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary one half hour prior to the start of any regular conformation judging at the show. (American Kennel Club Rule, Chapter 11, Sec 6)
11. **DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.
12. **DOGS MUST BE READY FOR JUDGING.** The Club and/or its Show Secretary will not be responsible for, and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Owners or their agents alone are responsible for the presence of their dogs in the judging ring. Judges will not wait for any dog holding up a class.
13. **NO DOGS WILL BE ALLOWED IN THE SHOW AREA** except those regularly entered in the show. There will be **NO SPACE** for unentered dogs at this show. All dogs shall be kept on leash or confined, except when being judged or in the exercising ring.
14. **ALL AWARDS WILL BE MADE** in the judging ring to the person exhibiting the dog and that person shall be considered the owner or the agent. All claims for trophies must be made in the judging ring before the completion of judging, and the Show Secretary should be advised at once of any discrepancy. The show-giving club and its officials disclaim any liability for any awards not claimed on the day of the show.
15. The Club will take every precaution for the safety of dogs exhibited, but it is understood that the Great Dane Club of Northern California, Inc. will not be responsible for loss or injury. The welfare of the exhibitor's child is assumed to be the responsibility of the exhibitor. Please secure proper crates or means to confine dogs for the welfare of all concerned.
16. No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.
17. As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

## Additional Notices to Exhibitors

The Great Dane Club of Northern California, Inc. and its Show Secretary assume no responsibility for a wrong entry. Exhibitors are advised to clearly print or type all information when filling in the entry form and should pay particular attention to any unusual words.

PLEASE NOTE: Only AKC degrees and titles may be printed in the show catalog.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, in season, excused by the Veterinarian or Judge, or barred from competition by the Event Committee. If because of riots, civil disturbances or any other acts beyond the control of the management or the club, it is impossible to open or complete the show, no refund of entry fees will be made.

Neutered dogs and spayed bitches are allowed to compete in Veteran Classes at Independent Specialties which do not offer competition beyond Best of Breed. Neutered dogs and spayed bitches may compete in Stud Dog and Brood Bitch classes, respectively.

Dogs need not be at the show until the scheduled time of judging. Dogs not needed for further judging will be excused. This is for the safety of the dogs exhibited, and it is understood that the club will not be responsible for loss or injury.

Trophies and prizes will be awarded in the judging ring to the person exhibiting the dog, who will be considered the rightful recipient of the award. Any discrepancy should be reported to the Show Secretary before the completion of the show.

No dogs will be allowed in the show area except those regularly entered in these events. There will be NO SPACE for unentered dogs at these events. ALL DOGS shall be kept on leash except when they are in the judging or exercise ring.

PLEASE NOTE: Use only one entry form per dog if possible. If entering an Open Class, please remember to specify the COLOR. Check the boxes for which of the shows are to be entered.

## Grounds, Cleanup, and Safety

These events will be held on private property. Please be respectful of the owners and their home and business.

- \* Do not block the entrances to the business center of Sycamore Lane Kennels.
- \* Clean up after your dog(s). Dispose of dog waste in buckets specifically for that purpose; do not use the garbage bins.
- \* Dispose of garbage in containers placed on the show grounds.
- \* Canopies and ex-pens will be allowed in specified areas. Ex-pens set up on lawn must be matted; mats must be removed at night to prevent damage to the lawn.
- \* Do not allow your dog(s) to dig at the lawn area.
- \* Absolutely no dogs or people are permitted in the dock diving area.

**CLEAN UP IS YOUR RESPONSIBILITY.** Violators may be reported to the Event Committee for disciplinary action. Have someone supervising your setup area at all times at the event site.

**DO NOT LEAVE DOGS IN CLOSED VEHICLES.** If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Event Committee for disciplinary action. All persons attending these events hereby waive any claim for damages against the Great Dane Club of Northern California, Inc, its members, Show Secretary, or the property owner in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

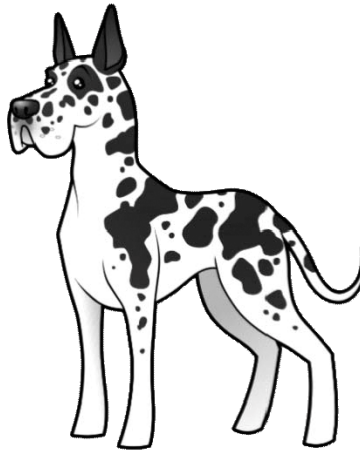

## ***Saturday AM Specialty Judge: T. Lynn Adams***

My parents gave me my first dog when I was 6 months old: a standard poodle named Jolly. I was hooked and have had dogs ever since. I got my first Dane in 1976 she was a black and a great dog. I did lots of obedience with her. Due to work, I did not get another Great Dane until 1996. She was a harl from a newspaper ad. She was a very trying young dog but had lots of personality. Again, I resorted to obedience to help with the behavior problems. Pearl turned out to be a great dog.

In 1996, I joined the Heart of Alabama Great Dane Club and not long after I got my first dog from a breeder. She was my first Champion, CH Calico Rock's Noble Rose. I went to my first



National in Atlanta in 1997 and there I saw CH Rojon's Royal of Stone Valley in the stud dog class and I was hooked. I got a Royal daughter and started a serious journey into the dog show world. Not long after, I owner-handled CH Calico Rock - Redland's Quest to his championship.

My family is from Savannah Georgia, home to Moon River. Johnny Mercer, who is also from Savannah, wrote the song about the river and Andy Williams sang the song in Breakfast at Tiffany's. The now famous cemetery that appears on the cover of Midnight in the Garden of Good and Evil is located on the banks of Moon River.

In 2007 I bred my first litter under the MoonRiver kennel name. I have since bred 33 champions in 12 litters.

## ***Saturday PM Specialty Judge: Mari J. Hayhurst***

Ever since I can remember, our house was filled with animals. We always had cats, little baby birds, and a dog. My favorite uncle had a fawn Great Dane, very sweet. To my three-year-old eyes, that dog was huge! When I



was four, my mother asked me if I wanted a puppy or a brother. Five months later, I was presented with a baby brother. Although I love my brother dearly, I've been trying to make up for that disappointment ever since.

When I met David in 1977, he owned a fawn Great Dane, Tamberlayne's Reprisal, a CH Mountdania's Timber grandson. I loved Tam, and I knew immediately that I wanted to share my life with this incredible breed. David and I got married in 1979, bought a house in

1987, and when I got laid off from my teaching job in 1988, I took it as a sign that we were ready for a Great Dane puppy.

We specialed CH Jerdans Sweet Sensation, Shannon, in 1991. She was the Number Three bitch that year and became the foundation of our kennel. Shannon was my Fairytale Princess until I had to say goodbye when she was 11-1/2 years old.

We bred Shannon to a dog that was never shown, Shadam's Obadiah Daneadair, and kept a brindle girl, CH Lake Jerdans Sweet Surprise, JoJo, and a fawn boy, BISS CH Lake Jerdans First Edition, Buddha (so named by our vet because he had a fat tummy). Buddha became our second Top Twenty Dog, breeder-owner handled by David the first year, and then by Joe Napolitano and Steve Cochran.

All of our current Danes go back to Buddha, including my heart boy, BISS GCH Lakes Prime Time, Deion. In addition to our Danes, we also have a Rottie and a Boxer. It's never a dull moment here!



## ***Sunday Specialty Judge: Nancy D. Simmons***

Nancy has been active in both conformation and obedience over the years with her Great Danes, a Golden Retriever, and more recently Doberman Pinschers. Nancy was very proud of her Great Dane CH Simmons Garrett CDX CGC.
